### Application process

This application form is for Trade Stalls **only**. Catering traders must apply for a Catering Trade Stand using the Catering Trade Stand application form.

Please note that failure to complete or supply all requested information may result in the rejection of your application. The deadline for applications is **Friday 31 July 2008**. If your application does not reach us by this date, we may not be able to consider it for this year's festival, unless space becomes available.

### Event details

**General Description** Sugarhill '08 takes place on Warren Farm in the village of Liddington, just outside Swindon over the weekend of Friday 5 to Sunday 7 September 2008. There will be a programme of live music throughout the weekend on three stages (licensed capacity 5,000), along with a late night programme, family activities, workshops, trade stands, real ales and ciders, food and drink, etc.

**Terms and Conditions** Please make sure you obtain a copy of the Sugarhill '08 Rules & Regulations for Traders and Fair Trade Policy. You need to read these carefully before completing your application and make sure you comply with them.

**Camping** There is a designated staff campsite area.

**Wrist Bands and Car Passes** A maximum of four wristbands and two car passes will be issued to each catering trader. Further passes can be purchased at £25 each.
